**AN ORDINANCE AMENDING SECTION 505.140,
DANGEROUS STRUCTURES, RELATED TO THE TASKS
OF THE CITY ADMINISTRATOR THEREUNDER.**

WHEREAS, when the City designates a certain official to be responsible for a certain task within the City’s Municipal Code, the City usually designates that official or his/her designee; and

WHEREAS, Section 505.140 designates the City Administrator to conduct hearings and take other actions related to dangerous structures but not specifically authorize the City Administrator to designate anyone else to fill that role when needed or desired; and

WHEREAS, the Board of Aldermen finds it in the best interest of the City to amend Section 505.140 to authorize the City Administrator to designate someone else to fill those tasks under Section 505.140.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF FENTON, MISSOURI, AS FOLLOWS:

Section 1. Section 505.140, Dangerous Structure, of the Municipal Code is hereby amended by replacing every reference to “City Administrator” and “Administrator” with “City Administrator or his/her designee.”

Section 2. This ordinance shall be in full force and effect after the date of its passage and approval.
