The Olde Towne Fenton Farmers Market is located under the Olde Towne Fenton Pavilion (200 Gravois Rd, Fenton, MO 63026). The market is open every Saturday, May 18<sup>th</sup> to September 28<sup>th</sup>, 8:00-12:00 p.m. We provided a covered pavilion for our musicians. “Music at the Market” will be at the end of the pavilion in a stall (10 X 10). Must bring own equipment, tables or chairs. We have access to electricity. Entertainment is a valued part of the market. Musicians need to play from 9 a.m. –noon or 10a.m.-noon. All performers must submit a demo of a performance for review: Facebook, You Tube, websites and most other media are acceptable forms of demonstrations. Amplified volume must be kept at a level that allows easy transactions between vendors and customers. Musicians will be able to play for over 500 customers on a Saturday. Performers may put out a container to collect tips. Cds may be sold by the performer. Olde Towne Fenton Farmers Market will also promote the band on facebook page.
