All performers must submit a demo of a performance for review: Facebook, You Tube, websites and most other media are acceptable forms of demonstrations.

Entertainment is a valued part of the market. Musicians need to play from 4 p.m. – 6 p.m. or 6 p.m. - 8:00 p.m. Amplified volume must be kept at a level that allows easy transactions between vendors and customers. Musicians will be able to play for over 500 customers on a Thursday. Performers may put out a container to collect tips. CD's may be sold by the performer. Band will also be promoted on the Fenton Community & Farmers Market Facebook page.
