MINUTES OF THE SPECIAL MEETING OF THE BOARD OF ALDERMEN
WEDNESDAY, MARCH 16, 2022
6:30 P.M.

CALL TO ORDER

Mayor Bob Brasses called the Board of Aldermen Meeting of the City of Fenton, St. Louis County, Missouri to order at 6:30 p.m. on Wednesday, March 16, 2022. The meeting was held at Fenton City Hall and via Zoom Videoconference (RSMo 610.015).

- **Bill 22-14 – An Ordinance authorizing the Mayor to execute an agreement with Spencer Contracting Company for Fenton Sports Complex batting cage construction.**

Alderman Huels desired first reading of Bill No. 22-16. City Attorney Erin Seele read the Bill one time by title only.

Alderman Huels made a motion to seek a waiver of the rules for a second reading. The motion was seconded by Alderman Wisbrock. Upon a vote being taken, it was announced that the motion was passed unanimously by the Board of Aldermen. City Attorney Erin Seele read Bill No. 22-16 for a second time by title only.

Alderman Huels made a motion that Bill No. 22-16 be enacted as Ordinance No. 4205. The motion was seconded by Alderman Clauss.

Alderman Maurath inquired on estimate of prior cost in past. Public Works Director Dan Howard replied he did not have estimate, however it took two (2) employees approximately two (2) weeks to complete the painting. Alderman Maurath inquired if Staff performed grinding and crack filling when they painted the pools. Public Works Director Dan Howard replied yes, they did. Alderman Heard inquired if the project included the lap pool to be repainted. City Attorney Erin Seele replied yes and stated the same was in the body of the contract.
